Your tasks:

- To conduct independent research on a broadly contextualized history of epidemics in Bohemia during the late Middle Ages and the early modern period, drawing on archival sources and engaging in interdisciplinary collaboration with natural scientists
- To prepare and complete a doctoral dissertation within the framework of the project
- To integrate your individual research project with ongoing research activities within the department and across the GWZO as a whole

Your profile:

- A very good university degree in history (with a focus on pre-modern history) or a closely related discipline
- Excellent written and spoken English
- Reading knowledge of Czech is highly desirable; a strong willingness to acquire this knowledge quickly is required
- Willingness to work in an interdisciplinary research environment within the EUROpest project and at the GWZO
- A strong interest in Eastern Europe and in the research profile of the GWZO
